- 2. Minutes The December 12, 2024, meeting minutes were unanimously approved.

3. President's Report

Standing Item: Participatory Governance System (PGS)

Academic Senate Vice President Dave King reported on the PGS Flex session held in January, where employees shared their experiences on committees and gave feedback for improving the participatory governance system. An anonymous survey is planned to evaluate participatory governance at COM. Data should be available mid-March to analyze themes and evaluate by fall.

Cari Torres, Assistant Vice President of Instruction, is working to formally create an accreditation steering committee before of the next accreditation visit.

Klaus Christiansen will bring the Environmental Action Committee (EAC) proposal to the GRC.

Each fall committees should review their charge, discuss ways to make updates to the committee charge, and determine their committee members' responsibilities.

Start of Semester Check-In

Superintendent/President Jonathan Eldridge reported that enrollment is up, and Caring Campus and Wayfinding efforts were successful and well-received by students. Although the semester is off to a great beginning, faculty and students report that more late start classes are needed, add codes are difficult to get, and that many students feel afraid or stressed, and are having difficulty focusing because of the current political environment.

Executive Orders and Rule Changes





Changes to FASFA questions and some federal grants, due to changes implemented by the current Administration, will not impact College of Marin's non-discrimination protections and practices.

Title 5 protections remain in place though a court order to vacate Title IX protections of personal characteristics requires COM to revert to earlier policies and procedures. The Board of Trustees will waive the second reading requirement and act on the Title IX-related policies and procedures.

Update on Native American Engagement and Land Acknowledgement

Dana Emerson, Vice President of Student Learning and Success, reported that COM has worked closely with local Miwok and the official Native American tribal spokesperson to work towards developing a respectful land acknowledgment process.

As part of this thoughtful process, COM has hosted Native American panels and discussions. Ongoing intentional engagement and strengthening relationships with the Marin American Indian Alliance will lead to a meaningful land acknowledgment. COM is hosting an upcoming powwow on March 23 which is a significant step.

As part of the Centennial events, a learning landscape is planned to connect the campus to its indigenous roots. Staff are also working on the donation of a Harkin Lucero sculpture.

The Council discussed *AP 3845 Art on Campus*. It will include updates based on feedback from the Art Department faculty and the Finance and Operations staff.

Communication Coordination

The role of the College Council is to serve as a space for collective communication between College leaders. These monthly meetings allow for responses to any questions that arise and a chance for clarification. The last few semesters, College Council conversations have become more meaningful. The meetings go beyond a platform for reports.

President Eldridge reported that he met with Supervisor Colbert to discuss the College Avenue crosswalk safety concerns. Supervisor Colbert is reviewing several areas of College Avenue to be improved for safety.

Better communication about HVAC problems in the Academic Center, such as the expected time frame for repairs when heating or A/C is broken, will help faculty, students, and staff plan.

ASCOM

Ryli Bowen, the ASCOM President, reported on recent and upcoming events. ASCOM elections have started, and students can meet the candidates on March 26. Students are working to inform everyone better about fentanyl overdoses and where Narcan is located on campus. It would help to have more training on the use of Narcan to prevent opioid overdoses. ASCOM is exploring a self-funded speaker series on technology, arts, business, and more.

Classified Senate

Classified Senate President Sally Wong announced that Episode 4 of the *Classified Know More* Podcast, will host Vice President of Finance and Operations Eresa Puch as their special guest, on February 27. The Book Club will participate in the COMmon read and attend the in-person event with Ada Limón, on March 13. The Senate is planning an afternoon tea for classified professionals in mid-March, to replace the annual breakfast event, and has launched its spring See's Candies fundraiser.

She gave additional updates on Rising Scholars, Zero cost textbooks, and revised graduation requirements.
