<u>ASCOM</u>

ASCOM President Emma Neal reported that ASCOM has continued to be very busy with events. Upcoming events include Constitution Day, the 1619 Project, League of Women Voters, the Mill Valley Film Festival addressing the "young vote", a November 7 pre-Election Day ballot information event. The upcoming event is for Undocumented Students Week, October 17-21.

Recent events included a recent Alumni panel and <u>We Remember: Policing in the Latinx</u> <u>Community</u>, on October 10, that was extremely well attended. Student engagement continues to be extremely successful and the video of the Latinx Policing event on ASCOM's Instagram got over 1,500 views to date.

<u>ESCOM</u>

Gary Gonser, ESCOM President, reported ESCOM on the Art reception on October 19 with displays by community education students. The art will be up for one month for viewing with closing party. This is a pilot and new art exhibits will be held if the pilot is a success.

Two articles about ESCOM will be published in October, one by the San Francisco Chronicle. The intergenerational panel is robust and ESCOM is working with faculty Tim Watt to meet with Business 101 students.

Another pilot program is one of public relations by connecting ESCOM with senior service providers to create a broader understanding of ESCOM as a resource and to expand its membership. Currently ESCOM has 2,700 members with 200 memberships recently added.

Academic Senate

Academic Senate (AS) President Maria Coulson reported the following: that the AS is busy revising outdated by-laws, that some administrative procedures under review will require additional time for substantive revisions, there is an upcoming ACCJC accreditations standards presentation before the AS, that as part of the subcommittee review the Academic Standards Committee may change its charge and/or membership, and that an ad hoc best practices review of hi-flex and trimodal courses is underway.
