President David Wain Coon called the meeting to order at 3:02 p.m.

#### 3. Introductions

College Council members introduced themselves. There were two new Classified Senate and Student Senate leaders present.

## **Review Purpose of College Council (Charge)**

President Coon described the College Council charge shared on screen. The charge can be found on the <u>College Council webpage</u>.

#### **Semester Opening**

Vice President of Student Learning and Success Jonathan Eldridge gave an enrollment update. ESL enrollment surpassed prior semesters and credit enrollment is up. The demand for added sections is being assessed as well as courses that require additional offerings.

David King reported that students have had difficulty accessing Wi-Fi since recent changes implemented by IT. He has been unable to assist his students with Wi-Fi access and is concerned about equity and accessibility issues this raises.

Ryan Barbosa reported that the campus free Wi-Fi (BYOB) often does not work and is complicated for students to navigate. Otherwise, students are excited about ASCOM events and there has been great attendance this semester.

Sally Wong reported that she has received multiple complaints about the crosswalk between the main campus and the Welcome Center. Cars often do not stop and there appears to be a visibility issue, even with the flashing yellow lights. She suggested that rapid red LED lights may help to increase visibility.

#### 5. **Board of Trustees**

The Council reviewed the draft Board of Trustees regular meeting agenda for September 19, 2023, 2:00 p.m. in Academic Center 255, and via Zoom. The Board agenda includes the enrollment report, centennial committee report, and a strategic plan update in the study session portion of the meeting; new faculty introductions, the 2023-2024 Adoption Budget and fiscal update, an oral recommendation for professional services contract - Interim Chief of Police/Director of Safety that is a correction from the last Board meeting, the District's proposed openers for the negotiations with the United Professors of Marin, Local 1610, usual consent calendar items, and a resolution in Support of Hispanic Heritage Month.

# 6. Constituent Reports

#### Academic Senate

Academic Senate President Maria Coulson reported ongoing policy and procedure review and revisions, several faculty projects including rewriting of the faculty senate constitution that was last updated in 1991, continued focused work on student learning outcomes, and assessment council review.

#### ASCOM

Newly elected ASCOM President Ryan Barbosa reported that the main events to date were Welcome Week, with introduction to the learning communities, and Club Fest. ASCOM has planned all of its events for Fall 2023 with many opportunities for student engagement. So far there has been a higher attendance than expected with participation from administrators, faculty, and staff. The number of students that signed up for clubs was especially good.

#### Classified Senate

Newly elected Classified Senate (CS) Sally Wong reported that officer elections were held in July 2023, a new classified member has joined the Professional Learning Committee (PLC), and that the Classified Senate met for a three-hour long retreat. The CS leadership worked on event planning and fundraising proposals at the retreat.

A Welcome Back Breakfast will be held at both campuses on September 27, a Halloween fundraiser and costume contest on October 31, and CS is working on monthly Book Club events.
