The schedule will be available to students and counselors at the end of April. He thanked the faculty and department chairs for their hard work finalizing the course schedules. The final schedule will drive Student Services for the next two semesters and in preparation for reopening.

#### EEO Plan:

Nekoda Harris, Executive Director of Human Resources, gave an overview of College of Marin's Equal Employment Opportunity efforts and future plans that include outreach and recruiting efforts, internal training and how Human Resources has tried to overcome challenges the pandemic has creating.

#### Diversity, Equity, and Inclusion Statement:

#### Single Use Plastics:
