

Purpose

- Provide an institutional hub and centralized space for all matters CTE related.
- Enhance institutional efforts by supporting the development and delivery of successful CTE programs that engage students and connects them to their educational and employment goals.





Why CTEC?

Responsibilities of Committee

- Build awareness of career education programs, initiatives, opportunities and challenges.
- Provide updates on college-wide local, regional, state and federal CTE matters
- Identify growth and funding opportunities that are in alignment with the college's mission, students' needs and industry demands
- Develop, review and communicate timelines, guides, forms and recommendations for the Strong Workforce allocation cycle.
- Make recommendations to PRAC for resource allocations and funding
- At least annually, examine college, regional and state-wide data with attention to performance and outcomes.







SWAC /CTEC Comparison

Strong Workforce Advisory Committee (SWAC)

- 1. Convened as a committee with a few internal staff members as resources
- 2. Focused on Strong Workforce Categorical funds
- 3. Reviewed and discussed faculty proposals
- 4. Recommended Strong Workforce-funded projects and programs to PRAC

Career Technical Education Committee (CTEC)

- 1. Convene internal and external stakeholders
- 2. Explore opportunities for grants
- 3. Build more awareness of career education: opportunities, successes and challenges
- 4. Play a larger role in the conversation about community and high school partnerships








COM Categorical Funds Invested
