EIR Update

- District conducted 6 EIR meetings prior to publication of the Draft EIR (4 onsite meetings & 2 Zoom meetings)
- Consultant incorporated the questions and provided responses to the comments received by the public and California Department of Fish & Wildlife
- Draft EIR is out for review with the 45-day review period starting on April 3, 2020 and review ending on May 18, 2020
- Tentative schedule for EIR Certification by the Board of Trustees is scheduled for the June 16, 2020 Board meeting

LRC Building Design Update

- Architect had been proceeding with design meetings on the new Integrated Learning Resources Center + Student Services project
- District Staff had been evaluating building estimates and have given direction to architect which has resulted in a max building size of 85,000 Gross SF
- Since in person Town Hall meeting was postponed Architect developed a virtual Town Hall presentation and prepared an online survey
- Lease-Leaseback RFQ/RFP for Contractor put on hold until June 2020

Design process put on hold until July 2020




Essential Work Exemption Resolution

- The Health Officer of the Marin County of Health Services issued a "stay at home" Order 20-04 on March 31, 2020 which placed additional restrictions on Construction Projects
- Staff evaluated the list of Measure B projects and prepared an analysis for all projects and reviewed with Legal & Senior Staff
- Superintendent/President prepared a letter to contractors informing them on which projects could continue as "essential government functions"
- Letter was sent to contractors on April 6, 2020
- A Board Resolution was prepared to formalize this initial determination
