CER 5: Make the College a center for community engagement and cultural enrichment.

Objective 5.1 Increase activity at both College campuses including student activities, community events, and facilities use.

Objective 5.2 Plan and host College's Centennial Celebration 2026.

Discussion:

- o Event Registration System:
 - COM is currently searching for an institutional system for event registration and text to donate that will have reporting functions and will have consistent branding.
 - IT department is spearheading this.
 - It will be used for tracking campus events and community events on campus.
 - Data collection in the system will allow us to track participation to find out who the participants are.
 - Attendees will be required to register, then answer questions that can later be used for Strategic Plan data.
 - Associate donors with which events they have attended.
 - Gives the ability to give different campaigns the ability to track their own donors. Also allows communication with the event attendees.
- COM's Centennial Celebration
 - Centennial events will be an 18-month timeframe, starting in September 2025 and running through graduation spring of 2026 which is the 100-year anniversary.
 - Marketing Coordinator and Alumni Coordinator are currently being hired to help with Centennial work.

- Nicole Cruz shared Centennial Planning Timeline.
- Theme will be Honoring Our Past, Defining Our Future
- Importance of tracking and communicating with Alumni. Plan to begin collecting data on Alumni who have a degree completion, then broaden the communications to more students in future.

 - Still 1 more HVAC position to fill.
 - May need to hire temporary workers.
