# Champion Presentation by: Cari Torres-Benavides and Jon Horinek

SAS 3: Provide effective orientation and early support to students so that they can determine and achieve their educational goals.

**Objective 3.1** Develop mandatory first-year strategies.

#### Discussion:

Orientation discussion

- Students opt in. Not mandatory.
- Orientations are mostly virtual.
- In-person orientation not many students showed up. It's not required, so there is no incentive to attend.
- If students attend College Success Saturday, they get priority registration.
- Undeclared students could benefit from orientation.

# Champion Presentation by: Cari Torres-Benavides and Jon Horinek

#### SAS 4: Build awareness in students of educational goal options and paths to achieve these goals.

**Objective 4.1** Increase the number of students who have current educational plans that align with their educational goal.

#### Discussion:

Students can now change their major using an online form which then goes to an evaluator.

• Primarily the counselors are using the form when they are meeting with a student, but it does not require being used in the presence of a counselor.

- There is no method currently for prompting a student to ask if they are still in a certain major, if they're not taking the classes for that major. There are enhancements in Degree Works to tell students that they are off of their degree plan.
- Most students using the form to change their major are working with a counselor.
- At the time of registration, Banner asks students to confirm their major. They can change their major then.

## **Champion Presentation by: Jon Horinek**

#### **IVC 3:** Improve student access to IVC, including transportation.

**Objective 3.1** Improve student access to IVC as part of the plan for IVC Goal 1 educational use of IVC.

#### Discussion:

Improvements have been made in having services up at IVC.

WIOA (integrated college and county services including access to EDD and/or other workforce career services) is complete and fully operational at IVC.

Transportation continues to be an issue.

- Jon would encourage us not to focus on the transportation.
- Shuttle has been a suggestion, but it's difficult to make that work.
- More communication needed that IVC is another COM campus, not separate college.

Discussion of moving Nursing Program to IVC.

- Having Clinical sites nearby is a consideration
- Moving to IVC doesn't necessarily fulfill this goal
- Would have to physically reconfigure all facilities.
- Nursing program is increasing in enrollment.

Fast Facts last year 2500 students took classes at IVC, 7000 at Kentfield, 3400 DE courses.
