Student Equity Plan

- The Committee chair grouped the Student Equity Plan activities and the departments/groups that support these activities into 5 categories. The Committee Chair is extending invitations to the departments/groups to participate in conversations with GRIT regarding the Student Equity Plan.

Program Review for Machine and Metal Technology Department

The Committee's comments included questions about the Program Review data and its lack of alignment with the PRI data. An additional concern noted was the issue of low enrollment and fill rates within the program. Work on the Program Review Analysis for the Machine and Metal Technology Department was continued over to the next GRIT meeting.
