- PL Funds update

- Use the Creating Connections and Cultivating Excellence again?
  - Might be good to connect with action steps.
  - Suggestion: "Strengthening Connections and Embedding Equitable Practices" (will revisit this next meeting)
  - Requiring/prioritizing presentations for Flex that match the IP Goals and objectives
- Convocation: Continue with discussion around 1619 Project and incorporate student voices?
  - Suggestion to bring in students giving their "Aha" moments from reading 1619 Project– either in-person presentations or videos. Perhaps interview many students and produce a video.
  - Using that lens to spark the inspirations that have happened after reading this book.
  - o It's an opportunity for all of us to learn.
  - Weaving in Land Acknowledgements
    - Next steps: Evaluations of Convocation to guide this; continue to pursue interest in elevating student voices as part of Convocation, but not specifically 1619-focused.
