- Flex Week Planning
  - Debrief wins/challenges/takeaways for August
    - ♦ Pre-Flex week was very well-attended: 180 people
    - ♦ Convocation: 310 attended
      - Discussion: Is Jonas Center too small? Room was full and people were sitting outside as well. Keep this in mind for future planning.
      - There were no breakout sessions after Convocation
        - \* At IVC, with no session after Convocation, Managers and staff (non-faculty) had nowhere to go during 12-1:30 if they were attending a 1:30 Dept. Meeting. Suggestion to offer a space for people to go to do work and food provided if they need to continue on for afternoon meeting.
        - **★** Suggestion to have box lunches for everyone. Whether they take it to go, or need to stay for the meetings later.
    - ♦ Hyflex session room at Kentfield (AC 245) was a success
    - ◆ Discussion of whether PLC should lead the design of theme, keynote, etc. of Convocation.
      - In perfect world, Convocation is centered on the President, who would bring his ideas to PLC and have a dialog about them.
      - Flex Week can still have its own theme (faculty professional learning is a 10+1 item). Convocation can have a separate theme, keynote speaker, and program.

    - For Fall CPL: consider holding it on Friday. (although many staff don't work Friday and many work remotely on Fridays)
