- CHARGE:
  - Ensures that the College's planning process supports student success.
  - Aligns College plans and the budget process with Board goals and priorities.
  - Ensures that the planning process is broad-based, offers opportunities for input by appropriate constituencies, allocates necessary resources, and leads to improvement of institutional effectiveness.
  - Prepares planning recommendations and decisions consistent with the Education Code, the mission, vision and values of the College, accreditation standards, and strategic institutional planning priorities.
  - Reviews and makes recommendations for long-term budget planning, revenue and expense assumptions, the tentative budget, and resource allocations, including from supplementary sources.
  - Reviews and makes recommendations for adjustments between approved funding and actual expenditures.

- Working on recruiting 1 additional student.
- Working on recruiting 3<sup>rd</sup> classified.

**President Dr. Coon – Police Task Force & Related Items**

- We have been short staffed for the last 2 years.
  - Lost 2 long time part time positions.
  - Hiring in the interest of officers' safety and well-being as well as to maintain a safe environment for *everyone* (students, faculty, staff and greater community).
  - Hoping for a bilingual/ Spanish-speaking officer.
- Still would like to move forward with a committee in addition to the Police Task Force.
- Everyone to receive the Taskforce Report.
- (Colleen/ Meg) Expressed concern for the hiring of a new officer. This was not part of the original PRAC recommendation: *Last year, acknowledging the larger societal questions of policing and current conversations about policing on college and university campuses, PRAC's recommendation was to empower a task force to assess policing/public safety and its future at the College in alignment with the Chancellor's Office Campus Police Reform Task Force. This year, PRAC recommends the task force's report be shared with the campus community and any recommendations within it discussed and vetted broadly before any positions are filled or other/additional resources are committed to the police department.*
- Dr. Coon to meet with Police and Task Force on 9/14/22 to address concerns brought forth by PRAC.
