## **Summation of Deans' Requests - Marshall**

Marshall summarized the Deans' prioritized PR requests. Total requests came to \$1,710,928. Available funding is \$325,000. The PR requests have been whittled down to \$341,360, which is \$16,360 over available funding. The committee reviewed possible reductions, but came to no definite conclusions at this meeting.

One option discussed was that the proposed FT Court Reporting retiree replacement hire be actually replaced with PT'ers, and the coordinator units reduced or eliminated. PRAC members agreed that this was a good option for expenditure savings. More discussions will continue at the next meeting to prepare a recommendation to the Acting Superintendent/President.



#### **IEC Plan/Process – Beth Pratt**

Beth discussed the work of the IEC this year and the methodology involved in their distribution of available funding for equipment requests. Department PR's were reviewed carefully for the program explanation behind equipment requests. PRAC members were sent a spreadsheet with allocation details.
