Discussion Items

2. Sound Board: Summer updates/concerns

I. The registration process must be simplified for students who are not tech savvy, especially for ESL students. It was proposed that we bring this issue to the attention of Jon Horinek and Gina Longo. Jamie, Hector, Tessa and Grace spoke to the inequity factors for students including support not available "off hours" and no support to learn how to use technology including email.

The committee discussed regulations by State to use CCCApply for students particularly ESL. It's our understanding that the Chancelor's Office *does not require* CCCApply for all colleges. Perhaps, this is not required for all ESL programs. The committee is interested in re-reviewing the Tech-quity report and exploring to find institutional space/opportunity to bring about real change for students who need more support.

II. Faculty and Staff often purchase or adopt free software and software applications, i.e. Newsla, an academic tool used for ESL. COM I.T. should first provide VPAT, Voluntary Product Accessibility Template, to vet the software and applications for accessibility usage. However, COM I.T. doesn't always know of the new software adoption. The committee can support by understanding the roll out and process. TPC could outline the steps faculty/staff would need to follow. Matthew Howard stated that COM has a vetting process in place, but instructors and staff are not necessarily following nor aware of the process. Accessibility for all students is the emphasis. Where can our committee lean in to create cohesiveness within COM to address this issue?

3. Committee to set 3 Goals for TPC AY2024-25

The co-chairs ask the committee to create 3 - 4 goals. Three viable goals can include:

- COM Technology Plan development * (required)
- Gain students' perspective on technology experience at COM and report out
- Support the development any COM AI new policies for faculty/staff
- Recommend and encourage tangible changes creating equitable student support revolving around registration and accessibility. Focus may include:
 - To influence change for ESL registration and programs with similar challenges for student community
 - Bring about awareness and increase the implementation of accessibility policy that includes vetting prior to adoption (or creation) of any software/applications to prove accessibility and then follows I.T. integration requirements
